REPORTS

President:

- Formalizing our marketing efforts have invited Travis Montgomery to talk to us about this
- Using Messiah Sing-Along as a laboratory for messaging
- Free show, so just let people know about it
- Other shows with tickets, we can see how it's going because of ticket sales
- Working on a unified script for promoting the show
 - Revamp of e-mail with focus on the program and drive traffic back to website
 - Guide of how members can promote the program
 - Setting on a text that describes the program and presents it in a unified way
 - Help members to talk about the program and music
 - Can be used in different forms, similar to the "elevator pitch"
 - Thinking of joining a couple of committees to work on promoting and tracking audience development for each concert
- Ellie interested in collaborating between programs/publicity and audience development
 - Have a similar script each time
 - Need to have this for the entire season by July going forward
 - Have a paragraph for each concert already from this season's brochure

- Good idea to coordinate between Ellie's committee and Audience Development
- Working in general to reduce siloing across committees
 - Make an effort to talk about publicity in the board meetings before materials go out
 - Ensure a cohesive message and accurate information being disseminated
 - Improve awareness between groups that handle similar tasks and information
- Marketing could be structured more like the Finance Committee
 - o Two committee chairs with different focus areas/functions
 - Additional members to participate and share guidance
 - o Better coordination occurs in this model
 - Additional support from the additional people on the committee in terms of getting the work done
- Perhaps should consider having an approval process/structure for publicity and concert materials to ensure accurate information and cohesive message
 - o Ex. list of who needs to review before it is sent to the printer
 - Make sure that there are enough people to review but not so many that it slows down the process
 - Who needs to look at the products during the drafts stage versus final approval before going to the printer
- Publicity includes many pieces and products and all of these items are siloed
 - o Brochure, flyers, programs, e-newsletter, website, bookmark, social media, etc.
- Would be very helpful to have a semi-regular group that reviews these items for the sake of continuity, as well
 - Travis very open to a combined committee that meets somewhat regularly
 - Not sure how often to meet
 - Can determine what things need to be done for each concert and replicate each time
 - Some choir members are interested in being on the Audience Development-Marketing (combined) Committee
 - Susan can get these names from the member survey
 - Liz, Ellie, and Natalie should be on this committee
 - Susan should be involved since she manages the e-mails and updates the website
- Next steps
 - Determine who will take the reins to make this joint committee happen
 - Ellie and Travis will work together
 - Need to figure out who else has interest
 - Board members have access to the member survey through G-suite
 - o Will need to determine when to meet
- Travis is now the Webmaster
 - Working to make the site more readily readable
 - Tightening up the page layout
 - Minor tweaks to make it easy to get the information quickly for visitors to the site
 - Would like to have a structured events calendar
- Next year: Planning to constitute the Events Planning Committee
 - Rodney's 35th Anniversary is coming up
 - Possible fundraising opportunity
 - Will use funds to do something for Rodney
 - Board members who want to participate in determining how to honor and celebrate Rodney can let Dave or Linda know
 - 1st meeting will be Monday Dec. 16

Artistic Director:

- Pretty sure Monday will take time to look at some movie clips while we listen to some of the Hollywood music
- Had first check-in rehearsal at Jordan High School today
 - o They are just beginning to work on the music because they had a concert last night
 - They meet every day and are capable of learning the music
 - Their new conductor has high expectations
 - Plan to sing everything with CSD except the Chamber Choir pieces
 - Group of about 25 singers
 - Only one bass
- Sing along
 - Expect this to be bigger than last year
 - Sunday after Thanksgiving
 - No Duke soloists because students are on break that weekend
- Society Singers have had two inquiries
 - First one, Rodney wasn't available so a choir member is going to perform instead, but not representing CSD
 - Second one was for a Sunday morning, which was problematic timing for the group
 - Publicity has an open ad space in the program and wondered if we should use that space to publicize the Society Singers
 - Would need to create that ad design
 - Too short a timeframe to get into the December program
 - Could do this for other concerts this season
- Have sung at eight different retirement facilities over the last several years
 - Originally expected this to be a 2-year rotation
 - o It will be a longer rotation if we keep this many places on our list
 - Plan to add a new location in the spring
 - They are planning to sell tickets and pay CSD a fee
 - Should we continue working with all the locations and continue developing contacts?
 - Some locations pay a fee while others do not
 - See the income generation as an incidental benefit
 - Board feels that the outreach is more important than the income
 - Could expand to other audience types, but need ideas
 - Alan will look into potential alternatives that are more diverse communities
 - Agreement that we need to try to reach different audiences

Administrative Assistant:

- 990 tax form for the 18-19 season is in
- Request from Glen Leaf to set aside 30 seats on Friday night for his community
 - Several rows behind reserved seating section
 - This is common for groups to do, but CSD has not experienced it before
- 46 travel mugs left
 - o Could sell at concerts with the CDs
 - Announce to capitalize on holiday sales
 - Sell at the Sing Along
- 54 people have responded to the member survey

- Some really good comments for Social Media
- Susan will read through and consolidate the information
- Going Dec 4-5 to NC Center for Nonprofits conference
- 21 Sustaining donors
 - Not all of them are new
 - About 10 of them are new since August
 - \$700/month is coming from these sustaining donors
 - Will announce that the match is still ongoing in the next e-newsletter

Treasurer:

- Still within our budget
- Early in the year
- Individual donations are at 22, 232 versus 27,515 last year
 - Down about 5,000
 - o 2-3 major donors who usually give by this time who have not yet given, or would be ahead
- Funds are up about 3% from last month in Edward Jones and 1% for Triangle Community

Financial Oversight:

- . John has shared with us that he would like to retire at the end of this fiscal year
- He has been treasurer for nine years
- Need to get ideas of members who could fill his shoes
 - o Board members can give ideas to Doug or Dave
 - o Can review the member survey for talent and interest

Financial Development:

- Income from the retirement centers comes under the Development Functions line item
- Sing along is going along
 - Will hear more about this over the next week or so until December 1
- Auntie Flo dinner has a location at an appropriate home
 - Linda and Florence have checked out the space
 - Planning is moving forward
- Hill House for May seems to be okay because the reservation is on the books and they have not canceled

- Flyers are finished for December
 - Sample available to review
 - Correction to the flyer
 - Under 30 font type
 - Rodney as Artistic Director
- Working on the program now

- Needs to be complete before Thanksgiving
- o Carol will send singer's list to Ellie

- Trying to make the site more dynamic
 - Perspective from members
 - New content on a regular basis
 - Will use the blog function
- Member gallery updates
